Reinstatement Program Guidelines

This program is designed for members who let their Alpine, Snowboard, Adaptive* and/or Nordic* Level 2 or 3 certification expire. If your certification has not been current for 4 years or less, you can pay divisional back dues and current year full dues. You are also required to update your continuing educational requirements. Reactivation candidates have two seasons, including the season they start, to complete the reactivation process. If the process is not completed in two seasons, they will have the option to start into the process again starting with Step #2.

Level 1 certifications can be reactivated. Members can join the reinstatement program and follow steps 1-3. Any combination of educational courses totaling 24CEUs will be accepted for Level 1 Reinstatement and step 4 is not required. Alternatively, former Level 1 members can join as a new member by paying the current season's membership fees and either retake the Level 1 exam or begin the Level 2 certification process. If the latter is chosen, it's important to note that no certification will be recognized until a certification assessment is passed.

STEP #1 all disciplines

If your membership expired prior to 6/30/2017, you must pay \$300 to cover back dues plus this year's dues, \$125. If your membership expired after June of 2017, please contact the office.

STEP # 2 all disciplines

Your current Snowsports School Director and Training Manager submit letters of recommendation for reactivation.

STEP #4 All Disciplines

Register for the reactivation assessment session. The price of this assessment is \$195.00. This half day assessment is to be completed with a divisional educator at or near your home area. Applicants must demonstrate their ability to ski/ride at or above the Level 2 standard. All former Level 3's will be expected to ski/ride and be coached through the Level 3 tasks. Applicants who meet these requirements will be reinstated. Applicants who do not meet these requirements will be encouraged to visit the appropriate educational clinics. Applicants may then reapply for a future reactivation assessment day given that the two-season window on completion of the program has not yet expired.

***Nordic and Adaptive** must contact the office to determine STEP # 3 and #4.
