Reinstatement Program Guidelines 2023/24

The Reinstatement Policy lets former members rejoin and recover their certification. The process can occur at any time during the year. The reinstatement process is for you if you are a previous member who wants to rejoin as a Certified Member or if you are an Alumni Member who want to switch to a Certified Member.

Note:

- The reinstatement process is the same for all disciplines.
- If you want to rejoin PSIA-AASI and do not want to pursue or maintain your certification you can do so as an Alumni Member (if you meet the qualifications) or as a Registered Member and bypass the reinstatement process.
- If you are an Alumni Member and want to change your membership status to Certified Member, you must follow the reinstatement process and pay 50 percent of the reinstatement fee due.

Reinstatement Process

1 Year Membership Lapse. You must:

- Pay the membership dues invoice in your account.
- Continue to meet CEU requirements (6 CEUs a season and whatever CEU's may be outstanding).

2-4 Year Membership Lapse.* You must:

- Pay a \$210 reinstatement fee.
- Pay the current season's membership dues of \$130.
- Membership Years will reflect original join date.
- Membership will reinstate to Inactive status until CEU's listed below are attained.
- Follow the certified inactive process and earn CEUs for each year you did not pay dues. CEU's must be earned within the season of reinstatement. If not attained, member remains in Inactive status and is responsible for paying any associated fees:
 - 1 year: 12 CEUs
 - 2 years: 18 CEUs
 - 3 years: 24 CEUs
 - 4 years: 24 CEUs

5 Years to 10 Years Membership Lapse.* You must:

- Pay a \$380 reinstatement fee.
- Pay the current season's membership dues.
- Earn 24 CEUs from the list in step #2 on the next page within one season. You are responsible for working with your primary division and getting their approval for your recertification plan. The processes vary by division.
- Follow Steps #1 - #3 below (If Level 1 member reinstating, just complete 24 CEUs total)

11 or more Years Lapsed Membership You must:

- Members who have remained active snowsports coaching may apply to a region for recertification consideration. If accepted, a personal recertification plan will be developed by the region in which the member wishes to recertify.

STEP #1 all disciplines

If your membership expired prior to 6/30/2019, you must pay \$380 to cover back dues plus this year's dues, \$130. If your membership expired after 6/30/2019, please contact the office.

STEP #3 All Disciplines

Register for the reactivation assessment session (this step not required if reinstating Level 1 certification). The price of this assessment is \$210.00. This half-day assessment is to be completed with a divisional educator at or near your home area. Applicants must demonstrate their ability to ski/ride at or above the Level 2 standard. All former Level 3's will be expected to ski/ride and be coached through the Level 3 tasks. Applicants who meet these requirements will be reinstated. Applicants who do not meet these requirements will be encouraged to visit the appropriate educational clinics. Applicants may then reapply for a future reactivation assessment day.

***Nordic and Adaptive** must contact the office to determine STEP # 2 and #3.
